# THE POSITION(S)

Valley Water is recruiting for **two (2)** Associate Environmental Planners that will provide key environmental planning and regulatory permitting support for large water infrastructure and stewardship projects. This is a journey-level position that will lead project teams through environmental considerations and requirements during planning, design, and construction phases. Typical duties will include tasks and activities to comply with California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA) requirements, as well as natural resource agency regulatory compliance.

### THE IDEAL CANDIDATE

The Ideal candidate will have at least five (5) years professional-level environmental planning experience involving the evaluation of the impact of proposed public works, capital, and facility projects on the community and the environment. The ideal candidate must be able to prepare CEQA and NEPA documents on complex projects, ideally for water infrastructure and/or stewardship projects. The candidate must also possess experience in regulatory permit negotiation and acquisition on complex projects, ideally in the water infrastructure realm. In addition to the technical aspects of the position, the ideal candidate will have strong written and verbal communication skills and must be able to set priorities and exercise sound judgement as this position will serve as a lead in projects.

#### **EXPERIENCE & QUALIFICATIONS**

The following combination represents the minimum training and experience requirements:

Equivalent to a Bachelor's degree from an accredited college or university with major course work in environmental studies, environmental planning, city and regional planning, environmental science, natural resources management, geography, or a related field.

## AND

Five (5) years of experience performing professional-level responsibilities as an environmental planner.

Substitution: A Master's degree from an accredited college or university with major course work in environmental studies, environmental planning, city and regional planning, environmental science, natural resources management, geography or related field may substitute for two (2) years of experience. Two (2) years performing professional-level planning, not involving full time work on environmental regulations, may substitute for each year of the required environmental planning experience.

#### **Special Requirement:**

Possession of, or ability to obtain, an appropriate, valid California driver's license. Individuals who do not meet the driver's license requirement due to a disability will be considered for a reasonable accommodation on a case-by-case basis. Selected candidate will be required to successfully pass a medical examination.
