Dublin San Ramon Services District

The Dublin San Ramon Services District (DSRSD) is an independent special district founded in 1953. Serving more than 188,000 people in the Tri-Valley, the District provides water, recycled water, and wastewater treatment services to residents, businesses, industries, and governmental agencies. Specifically, the District provides: potable and recycled water service to Dublin and the Dougherty Valley area of San Ramon; wastewater collection and treatment to Dublin and southern San Ramon; and wastewater treatment and resource recovery provided by contract to the City of Pleasanton.

The Position

Under direct supervision, assists in the performance of more routine and varied duties involved with the cleaning, routine maintenance, and operation of the District's wastewater and recycled water treatment, sewer collection, DERWA and LAVWMA facilities. Incumbents will learn practices, procedures, techniques, regulations, and laws pertaining to wastewater, water, sewer collection systems, and recycled water treatment; and perform other duties as assigned. **To see the classification specification click [here](#).**

The Ideal Candidate

The ideal candidate will have relevant education, certifications and or experience in waste water, water, sewer collection systems, and or recycled water treatment operations.



Any combination of education, licensing, and/or experience which has provided the knowledge, skills and abilities necessary to perform the job satisfactorily may qualify the candidates to be considered for open positions in the class specification.

Equivalent to completion of the twelfth (12th) grade.

Certifications, Licenses, and Registrations

Possession of a Class C driver's license required by the State of California, Department of Motor Vehicles, to perform the duties of the position. Continued maintenance of said driver's license in compliance with established District vehicle operation standards, and the ability to be insured for the operation of a vehicle/District vehicle in accordance with the terms and conditions of the District's insurance program are conditions of continuing employment. The CSRMA driving standards are included herein by reference.

Ability to obtain an Operator-in-training certificate issued by the State Water Resources Control Board within two (2) months of appointment.

Possession and maintenance of a California State Water Resources Control Board Wastewater Treatment Plant Operator Grade I certification is required within two (2) years of appointment.

ADDITIONAL REQUIREMENTS

Incumbents in this class are required to participate in the District's Shave-on-Demand policy when required to wear respiratory protection or other safety equipment.

Work overtime, weekends, holidays, and shift work as assigned.
