Established in 1941, the Carpinteria Valley Water District is located in the southern coastal portion of Santa Barbara County and includes the City of Carpinteria. The District, which spans approximately 11,300 acres, is bound on the south by the Pacific Ocean and on the north by the foothills of the Santa Ynez mountains. CVWD uses 75 miles of pipeline to provide water to approximately 15,494 people.

THE POSITION

The District is seeking a qualified individual to perform: a variety of difficult and complex professional accounting duties in support of District financial, accounting, and related administrative functions. To assist with performance audits of District functions and services. To prepare detailed written, oral, and graphic reports related to studies performed for Business department; prepare grant and capital project accounting and reporting.
